#### Background:

The property deal with the City of Nanaimo has been discussed formally in Board meetings on January 25, 2017, February 8, 2017 and February 22, 2017.

On February 22, 2017, the Board commenced a consultation process to seek input from the

community with respect to the disposition of land, as outlined in the Memorandum of Agreement, dated February 10, 2017, and specifically in respect of the potential sale of property on Nanaimo District Secondary School and the construction of a lit all weather synthetic turf field on the lands.

Consultation included information about the potential sale and disposition of properties and the joint partnership to build an artificial turf field on the NDSS site on the School District website, a public engagement survey, the placement of newspaper ads, a joint open-house with the City of Nanaimo, and various meetings with community members and partner groups. NLPS received formal feedback through the engagement survey which resulted in 26 respondents, of which 26 completed the feedback portion. Informal and formal feedback from community members and partner groups is predominately positive. As the property identified is surplus to the school district's needs, community members and partner groups felt the sale would provide local capital monies to the school district to support other capital needs. Further, there was overall agreement that the City of Nanaimo is better positioned to manage Rotary Bowl and Serauxmen Stadium. There is excitement that Nanaimo will have another artificial turf field available to community groups while retaining the use of the field during the day for student use. Finally, there is general agreement that the location of the field was in-line with the vision for the sports corridor.
