

Letter from the Board of Education October 21, 2021

RE: Board Correspondence – Old Growth Forest Field Trip

Ashleigh Magill,

Thank you for your letter dated September 19, 2021. It was shared at a public meeting held on September 29, 2021.

On behalf of the Nanaimo Ladysmith Public Schools' Board of Education ("Board") I wanted to inform you that your letter has been shared with the Superintendent and the Department of Learning Services.

The Board affirms the educational value of well planned and supervised field trip learning experiences. Such experiences enrich the curriculum and provide an opportunity for young people to apply their school learning in situations outside the classroom.

All such activities must have clear educational value, proper advance preparation, informed parental consent (consent given with full knowledge of the risks involved and the probable consequences of the proposed activity), adequate supervision and a high standard of care.

While there is a risk factor involved in all activities, field trips that have a high level of risk will typically not be approved. However, the Superintendent or designate has the authority to approve field trips that are considered high risk, such as out of province or international field trips.

If this trip is not available, students will always have the opportunity to advocate for social justice causes such as this and are encouraged to do so in a variety of ways.

Once again, thank you for taking the time to share your consideration with the Board.
